Subject: Implementation of Central Nodal Account (CNA) system for flow of funds to the Empanelled Training Institutes (ETIs) under Central Sector Scheme (CSS) in the MoYAS - reg.

Sir,

I am directed to the refer to the subject cited above and to say that in accordance with an O.M. dated 9th March, 2022 (copy enclosed) issued by the Department of Expenditure, Ministry of Finance, all eligible Central Sector Schemes will be covered under the revised procedure for Flow of Funds w.e.f. 1st April, 2022. This is a mandatory requirement for release of funds to any implementing agency under the Central Sector Schemes. There are two Models prescribed under this O.M. dated 9th March, 2022 the guidelines of Ministry of Finance. Model-1 is implementation through Treasury Single Account (TSA) for those schemes having annual outlay of Rupees more than 500 crore and implemented without involvement of State Agencies. Model-2 is implementation through Scheduled Commercial Banks for those Central Sector Schemes having annual outlay of Rupees less than 500 crore or where the schemes are being implemented by the State Government Agencies.

2. It is informed that as the annual budget outlay of **National Service Scheme** (**NSS**) is of Rs. 283.50 Cr. under BE 2022-23 which is less than the 500 crore therefore, the NSS comes under **Model-2**. In reference to the Ministry of Finance O.M.

dated 9th March, 2022 and Model-2 thereof, the Grant for implementation of NSS activities now would be released to the States/UTs Government/Empanelled Training Institutes (ETIs) though CNA only and the CNA would be an autonomous body of this Ministry. Therefore, the Department is decided to designate the Nehru Yuva Kendra Sangathan (NYKS) as CNA for implementation of grant to the Empanelled Training Institutes (ETIs).

- 4. Accordingly, the Empanelled Training Institutes (ETIs) are requested to open a Zero Balance Subsidiary Account (ZBSA)(current account) in the State Bank of India. Further, after opening of new ZBSA account, the account would be mapped by the CNA i.e. Nehru Yuva Kendra Sangathan (NYKS) and the allocation of fund would be done by the CNA.
- 5. Further, all the Empanelled Training Institutes (ETIs) are requested to surrender the unspent balance alongwith interest incurred thereon available with you to this Ministry through DD/Cheque. The DD/Cheque would be in the favour of Pay and Account Office (Sports), MoYAS payable at New Delhi. A list of empanelled training institute is also attached herewith for information.
- 6. In view of the above, it is, therefore, requested to take necessary action to open CNA in respect of Nehru Yuva Kendra Sangathan (NYKS) and Zero Balance Subsidiary Account (ZBSA) in respect of Empanelled Training Institutes (ETIs) to smooth flow of funds to the ETIs for providing training to the Programme Officer as per the directions of Ministry of Finance's O.M. dated 9th March, 2022.
- 7. Further, SBI is also requested to furnish the report on opening of CNA and ZBSA accounts in respect of Empanelled Training Institutes to this Ministry.


